J. H. H. Weiler é catedrático e director do centro Jean Monnet para a xustiza e o dereito económico rexional e internacional da Universidade de Nova York. Anteriormente, ocupou unha cátedra na Facultade de Dereito de Michigan, e con posterioridade ostentou as cátedras Manley Hudson e Jean Monnet da Facultade de Dereito de Harvard.

Estudou Dereito nas universidades de Sussex (licenciatura), Cambridge (licenciatura e máster) e no Instituto Universitario Europeo (doutorado). Foi investido como doutor *Honoris Causa* por diversas universidades. Weiler é xefe de redacción da EJIL –a Revista Europea de Dereito Internacional– e de ICON –a Revista Internacional de Dereito Constitucional–. Desempeñou varios cargos como asesor dalgúns instituídos da Unión Europea. Tamén foi mediador en varias causas internacionais e, recentemente, representou á parte gañadora no proceso Lautsi ante a Gran Sala do Tribunal Europeo de Dereitos Humanos (sobre crucifixos nas aulas).

Entre as súas publicacións atopamos *Un'Europa Cristiana*, traducida a nove idiomas, *The Constitution of Europe – “Do the New Clothes Have an Emperor?”*, traducida a sete idiomas, e unha novela, *Der Fall Steinmann*.

J. H. H. Weiler is University Professor and Director of the Jean Monnet Center for International and Regional Economic Law & Justice at NYU School of Law. He was previously Professor of Law at Michigan Law School and then Manley Hudson Professor of Law and Jean Monnet Chair at Harvard Law School.

He earned his law degrees at Sussex (BA), Cambridge (LLB; LLM) and the European University Institute (Ph.D). He is recipient of doctorates *Honoris Causa* from several universities. Weiler is the Editor in Chief of the EJIL – the European Journal of International Law and of ICON the International Journal of Constitutional Law. He has served in various advisory capacities to the Institutions of the European Union. He has acted as arbitrator in various international disputes and recently represented the winning side in the Lautsi decision before the Grand Chamber of the European Court of Human Rights (crucifix in the classroom).

His publications include *Un'Europa Cristiana* (translated into nine languages), *The Constitution of Europe – “Do the New Clothes Have an Emperor?”* (translated into seven languages), and a novella, *Der Fall Steinmann*.
